Ed. 2D 147, that the decision of a woman to make an abortion is a private choice that is protected by the constitution, at least until the final of the first quarter of pregnancy. After a viable fetus (capable of surviving out of the building), the state can regulate the pregnancy of the woman and prohibit abortion except if the woman's life is in danger. Some advocates of abortion legalization, as well as some critics believe that the current legal situation is inadequate. To protect both the rights of the woman or the rights of the fetus is a moral issue that individuals decide for themselves. However, the extent to which people should be allowed to act on their beliefs and exercise their rights is discussed in the arena of decision-making and judicial decision.
